OFFICE ORDER

In terms of the second provisio under Rule 4 of the Indian Forests Service (Cadre) Rules 1966 and in view of the recommendations of the Joint Cadre Authority, the following posts of IFS officers in various segments of AGMUT Cadre are temporarily added for a period of 02 years:

- (i) One post of PCCF in HAG+ Scale is added in Arunachal Pradesh in lieu of one post of APCCF which is in conformity with the Cadre Review proposal of Government of Arunachal Pradesh.
