**ORDER**

WHEREAS, In compliance with the orders passed by the Central Administrative Tribunal, Calcutta Bench (Circuit Bench at Port Blair) on 01.06.2006 in O.A.No.29/A&N/2003 the vacancy position in the Joint AGMUT Cadre of Indian Forest Service for promotion of State Forest Service officers to the Indian Forest Service were reviewed and the vacancies determined was communicated to the Union Public Service Commission vide letter No.18011/9-2002-IFS-I dated 27.08.2007, for convening the review Selection Committee meeting to prepare year-wise Select Lists from 1989 to 1995-96. On the basis of the recommendations of the review Selection Committee and after complying with laid down procedures a Notification was issued vide No.18011/9-2002-IFS-I dated 12.06.2008 whereby 10 officers belonging to the State Forest Service of Andaman & Nicobar Islands were appointed to the Indian Forest Service in terms of Rule 8(1) of Regulation 9 of the Indian Forest Service (Appointment by Promotion) Regulations, 1966 and the said 10 officers were allocated to the Joint AGMUT Cadre of the Indian Forest Service under Rule 5(1) of the Indian Forest Service (Cadre) Rules, 1966. Further, vide Order No.18011/9-2002-IFS-I dated 12.06.2008 seniority and year of allotment of the said 10 State Forest Service officers promoted to the Indian Forest Service vide Notification dated 12.06.2008 were determined in terms of Rule 3(2)(c) and 4 of the Indian Forest Service (Regulation of Seniority) Rules, 1968.

AND WHEREAS, the Central Administrative Tribunal, Principal Bench, New Delhi vide its order dated 24.09.2009 in O.A.No.1866/2007 (Shri A.K.Ambasht & Others-Vs- Union of India & Others) quashed and set aside the aforementioned letter No. 18011/9-2002-IFS-I dated 27.08.2007, Notification No. 18011/9-2002-IFS-I dated 12.06.2008 and Order No. 18011/9-2002-IFS-I dated 12.06.2008.

NOW, THEREFORE, the Notification No. 18011/9-2002-IFS-I dated 12.06.2008 and Order No. 18011/9-2002-IFS-I dated 12.06.2008 having been quashed and set aside by the Central Administrative Tribunal, Principal Bench, New Delhi, the promotion of the 10 officers of State Forest Service of Andaman & Nicobar Islands to the Indian Forest Service effected vide Notification dated 12.06.2008 stands withdrawn w.e.f. 24.09.2009. Resultantly the Seniority and Year of Allotment of the said 10 officers effected vide Order dated 12.06.2008 also stands withdrawn w.e.f. 24.09.2009.


