**Staff – Officer – Resignation – Shri Mohit Sud –
Transfer of Service Bond**

Shri Mohit Sud who was working with National Bank for Agriculture and Rural Development (NABARD) as Assistant Manager has resigned from the service of NABARD which has since been accepted by the Competent Authority. The final relief order has also been issued to him after payment of all dues.

In this connection, it is mentioned here that Shri Mohit Sud had executed a service bond for serving NABARD for a period of **Five (5) years** and in the event of his failure to serve NABARD for a period of 5 years, he shall pay to NABARD by way of liquidated damages a sum of Rs. 50000/- (Rupees Fifty Thousand only). In terms of letter NO. BPE/GL – 017/MAN/2(11)75 – BPE (GM-I) dated 23 May 1981 issued by Bureau of Public Enterprises, Ministry of Finance, Govt. of India, it has been advised that the enforcement of the Bond should not be insisted upon in the case of an employee of a public enterprise who having applied through proper channel during the currency of the bond, joins the Central Govt./ State Govt./ Quasi- Govt. Organisation or another public enterprise, subject to the condition that a fresh bond is taken to ensure that the employee serves the new employer for the balance of original bond period. Accordingly, since your organization falls under the category referred to above, we have got a fresh bond in your favour executed from Shri Mohit Sud to serve your organization for the balance period of the original Bond. The same is forwarded herewith for necessary action at your end.

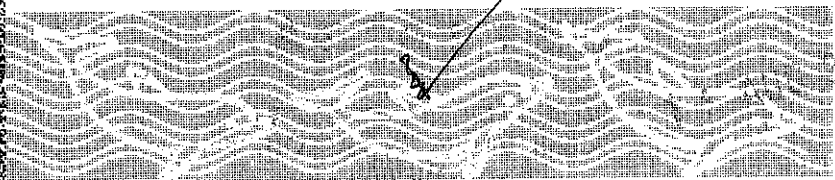
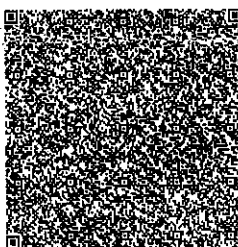

Dear Sir,

I had applied for the post of Indian Forest Service in the Ministry of Environment, Forests and Climate Change and have been selected for the same. Till now, I had been working in the National Bank for Agriculture and Rural Development (NABARD) as Assistant Manager. At the time of joining NABARD on 12/12/2016, I had executed a service bond for serving NABARD for a period of 5 years, ie upto 12/12/2021 and in the event of my failure to serve NABARD for 5 years I will pay to NABARD by way of liquidated damages a sum of Rs 50,000/- (Rupees Fifty thousand only). I had resigned from the services of NABARD during the currency of the Bond period and since the Bond could be transferred to the new employer in terms of letter No. BPE/GL-017/77/MAN/2(11)/75-BPE(GM-I) dated 23.05.81 issued by Bureau of Public Enterprises, Ministry of Finance, Government of India, I had requested NABARD, not to enforce the Bond and transfer it in favour of the new employer.

In consideration whereof, I hereby agree with and undertake as follows:

- i) I will serve Ministry of Environment, Forests and Climate Change for a period equivalent to the balance period of the original service Bond executed earlier in favour of NABARD, ie, upto 12/12/2021 and ;
- ii) In the event of my resigning from the services of the new employer or otherwise leaving the services for any reasons whatsoever before the expiry of the said period, ie ; before 12/12/2021, I shall pay to the Ministry of Environment, Forests and Climate Change by liquidated damages a sum of Rs 50,000/- (Rupees Fifty Thousand Only).

OFFICE ORDER

On the basis of the application dated 17.10.2017 of Shri Sanwar Mal Swami, the Director General, GSI is pleased to accept his Technical Resignation from service w.e.f. 15.12.2017 (AN) consequent upon his selection to the Indian Forest Services in the Junior Scale: Level - 10 on the basis of IFS Examination - 2016. Shri Sanwar Mal Swami is holding the post of Chemist [Level - 10: Rs. 56,100 - 1,77,500] in Geological Survey of India (GSI) w.e.f. 01.12.2015 on temporary capacity.

However, the release of Shri Sanwar Mal Swami would be on the condition that a fresh bond is to be executed with the new employer on the lines of the bond, executed by him at the time of joining to the post of Chemist in GSI, to ensure that Shri Sanwar Mal Swami shall serve the Government for the remaining/ balance period of the original bond and in case of non-acceptance of bond by his new employer, Shri Sanwar Mal Swami has to pay the Bond value of Rs. 7 lakhs (Rupees seven lakhs only) to this Department.

It is also made clear that there is no disciplinary proceeding either pending or contemplated against Shri Sanwar Mal Swami and no penalty has been imposed on him during his service period in GSI.

No 'lien' shall be retained against the post presently held by Shri Sanwar Mal Swami in GSI.
