3. In terms of DoPT's Office Memorandum No. AB-14017/2/2007-Estt.(RR) dated 29.02.2008, the said officer will be eligible for the maximum deputation period of 07 years (combined tenure under CSS/Non-CSS of DoPT) up to 15.09.2020 (two years beyond his current deputation expiry i.e. 15.09.2018).

4. Since the said officer is presently under the Central Staffing Scheme of DoPT, it is requested that Shri Shyam Sundar Kandpal, IFS (AGMUT:1995) may be relieved at the earliest after obtaining necessary clearance from DoPT.

6. Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government under non-CSS- of MoEF&CC.
