
Sir,

I am directed to refer to Government of Bihar letter No. Bha. Va. Se.(Stha.)-14/2016/2962/Pa.Va. dated 22.10.2018 and to inform that the Appointments Committee of the Cabinet (ACC) has approved appointment of Shri Chandra Prakash Khanduja, IFS(BH:1989) to post of Regional Director, Forest Survey of India, Shimla in the pay scale Rs 37400-67000/- with grade pay of Rs.10000/-(pre-revised) on deputation basis under Central Staffing Scheme of Ministry of Environment, Forest & Climate Change (CSS-MoEFCC) on the following terms and conditions:

- (i) He will draw pay as per the scale allowed by the Cadre Controlling Authority plus Allowances as applicable to that grade.
- (ii) The central deputation tenure of the officer will be for a period of 05 years from the date of assumption of charge of the post, or till date of superannuation or until further orders whichever is earlier.
- (iii) The headquarters of the post will be at Shimla however the services of the officer can be utilized anywhere in India.
- (iv) Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEF&CC.
