Sub: Disobedience of Ministry's directive by the IFS Exam 2017 probationers from joining the service at IGNTA on scheduled date - reg.

I am directed to refer to your e-mail(s) dated 10.12.2018 & 07.12.2018 received from Sh. Rahul Gajbhiye, Rank-102 and Sh. Bharat Bhoshan, Rank-14, IFS Exam-2017 respectively informing the Ministry to join the service with the next batch and seeking one year extension to join service with the subsequent batch.

2. In this regard, Ministry vide letter of even no. dated 19.07.2018 has already intimated/directed all the finally selected candidates to submit their request regarding extension of one year to join service with the subsequent batch or exemption from 93rd Foundation Course (FC), whichever they wish to avail, latest by 23.07.2018 failing which no request will be considered thereafter.

3. Sh. Rahul Gajbhiye, Rank-102 and Sh. Bharat Bhoshan, Rank-14, IFS Exam-2017 vide their e-mails dated 23.07.2018 & 10.07.2018 respectively requested the Ministry to grant them exemption from attending 93rd Foundation Course (FC) (i.e. exemption of 3 months not extension of one year). Accordingly, Ministry vide letter of even no. dated 03.08.2018 & 19.07.2018 respectively acceded the same **with the direction to report IGNTA, Dehradun for joining Professional Course on scheduled date.**

4. Thereafter, e-mail(s) dated 10.12.2018 & 07.12.2018 mentioned above were received informing the Ministry to join the service with the next batch and seeking one year extension to join service with the subsequent batch.

5. The Ministry has examined these requests and has decided that this act of Sh. Rahul Gajbhiye, Rank-102 and Sh. Bharat Bhoshan, Rank-14, IFS Exam-2017 of not joining the service/duty on scheduled date despite the Ministry's directive to report at IGNTA, Dehradun amounts to clear disobedience of Ministry's directive dated 03.08.2018 & 19.07.2018.


