

Minutes of the Meeting of the Screening Committee held on 13/05/2013 at 11.45 AM to prepare the "OFFER LIST" for APCCF/IGF level posts under the Central Staffing Scheme of MoEF

The Meeting of the Screening Committee for recommending names/panel for inclusion in the "OFFER LIST" for the posts at the level of Additional Principal Chief Conservator of Forests (APCCF) and Inspector General of Forests (IGF) was held on 13th May, 2013 in the chamber of Director General of Forests & Special Secretary, Ministry of Environment and Forests, Paryavaran Bhawan, CGO Complex, Lodi Road, New Delhi.

2. The Committee while considering the names for inclusion in the "OFFER LIST" against the vacant/likely to fall vacant posts at the level of APCCF and IGF under the Central Staffing Scheme of MoEF, took into account their Annual Confidential Reports (ACRs)/Personal Appraisal Reports (PARs) grading and other relevant records for ascertaining their suitability in accordance with the eligibility conditions notified for the purpose.

3. The Screening Committee also set the following criteria for inclusion of officers in "OFFER LIST":

- (i) The application through proper channel should have been received by due date i.e. 31.03.2013.
- (ii) Vigilance Clearance Certificate.
- (iii) Out of 72 marks (maximum) considering 8 ACRs/PARs, qualifying benchmark of 62 marks was fixed.
- (iv) At least 3 ACRs/PARs from the cut-off year (2011-12) out of 05 years immediately preceding and including 2011-12, should be available.
- (v) For APCCF level, IFS Officers of 1981-84 batch will be eligible and should have a minimum of 03 years of service left before superannuation as on 01.01.2013.
- (vi) For IGF level, IFS Officers of 1985-89 batch will be eligible and should have a minimum of 04 years of service left before superannuation as on 01.01.2013.
- (vii) Reference date for determining cooling-off period was fixed as 31.03.2013 as notified.
