ORDER

In terms of the second proviso under Rule 4 of the Indian Forests Service (Cadre) Rules 1966 and Rule 5 (2) of AIS (Joint Cadre) Rules, 1972 & as per the recommendations of the Joint Cadre Authority, the following posts of IFS officers in various segments of AGMUT Cadre are temporarily upgraded for a period of 02 years beyond 09.3.2019:-


- (i) One post of APCCF in Goa

3. One post of CCF temporarily diverted from Arunachal Pradesh to Delhi for a period of two year from the date of issue of this order.


