ORDER

Sanction of the President is accorded, in terms of the provisions of the All India Services (Study Leave) Regulations, 1960 to the grant of study leave to Dr. H. S. 3. Dr. Negi will submit a report on conclusion of his study leave, to the Ministry of Environment Forest and Climate Change, and shall report to his parent cadre, viz., Government of Madhya Pradesh on completion of the period of study leave.
