
Sir,

I am directed to refer to Government of Chhattisgarh letter No. 2501/1648/2016/10-Bha.Va.Sc. dated 21.10.2016 and to inform that the Appointments Committee of the Cabinet (ACC) has approved appointment of **Dr. Rajendra Kumar Dey, IFS (CHH:1985)** to post of **Additional Principal Chief Conservator of Forests (APCCF), Regional Office, MoEF&CC, Bhubaneswar** in pay scale Rs 67,000-79,000/- (pre-revised) on deputation basis under Central Staffing Scheme of Ministry of Environment, Forest & Climate Change (CSS-MoEF) on the following terms and conditions:

- (i) He will draw pay as per the scale allowed by the Cadre Controlling Authority plus Central Deputation Allowance as applicable to that grade.
- (ii) The central deputation tenure of the officer will be for a period of 05 years from the date of assumption of charge of the post, or till date of superannuation or until further orders whichever is earlier.
- (iii) The headquarters of the post will be at Bhubaneswar however the services of the officer can be utilized anywhere in India.
- (iv) Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEF.

2. The State Government is requested to relieve **Dr. Rajendra Kumar Dey, IFS (CHH:1985)** immediately to enable him to join the above post at Bhubaneswar.
