
Sir,

I am directed to refer to Government of Maharashtra letter No. DEP-1117/C.R.202/F-7 dated 25.07.2017 and to inform that the Appointments Committee of the Cabinet (ACC) has approved appointment of Shri K. P. Singh, IFS (MH:1988) to the post of Additional Principal Chief Conservator of Forests (APCCF), Regional Office, MoEF&CC, Bengaluru in the pay scale Rs 67,000-79,000/- (pre-revised) on deputation basis under Central Staffing Scheme of Ministry of Environment, Forest & Climate Change (CSS-MoEFCC) on the following terms and conditions:

- (i) He will draw pay as per the scale allowed by the Cadre Controlling Authority plus Allowances as applicable to that grade.
- (ii) The central deputation tenure of the officer will be for a period of 05 years from the date of assumption of charge of the post, or till date of superannuation or until further orders whichever is earlier.
- (iii) The headquarters of the post will be at Bengaluru however the services of the officer can be utilized anywhere in India.
- (iv) Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEFCC.

2. The State Government is requested to relieve Shri K. P. Singh, IFS (MH:1988) immediately to enable him to join the above post at Bengaluru.
