**Sub: Indian Forest Service Examination 2016 (Batch 2017) - Cancellation of candidature - regarding.**

Sir,

I am directed to say that on the basis of results of IFS Examination, 2016 and result of Medical Examination & Walking Test, offer of appointment to the Indian Forest Service was offered to you, vide Ministry's letter of even no. dated 12.06.2017.

2. Whereas, you vide your e-mail dated 21.10.2017 requested the Ministry to grant one year extension to join the service to you. Accordingly, the Ministry vide its letter of even no. dated 08.11.2017 & 15.12.2017 acceded the same and permitted you to join the service with the DR batch-2018 (IFS Exam-2017).
3. Whereas, after the expiry of above mentioned one year extension, no communication was received from you regarding your joining the service with the DR batch-2018 (IFS Exam-2017). However, you vide your e-mail dated 14.02.2019 (that is also after availing one more year extension without obtaining permission from the Ministry) requested the Ministry to allow you to join in 2019 batch (IFS Exam-2018).
4. Whereas, Ministry has examined your request dated 14.02.2019 and has decided that your act of not joining the service/duty on scheduled time despite the Ministry's direction to join the service with the DR batch-2018 (IFS Exam-2017), amounts to clear disobedience of the Ministry's directive dated 15.12.2017.
5. However, Ministry vide its letter of even no. dated 18.03.2019 directed you to submit your explanation about your unauthorized absence from the service/duty after the expiry of one year extension that was permitted to you by the Ministry vide its directive dated 15.12.2017, latest by 29.03.2019.
6. Whereas, you **have not submitted** your explanation about your unauthorized absence from the service/duty latest by 29.03.2019.

Accordingly, the Ministry has been decided that ample time has been given to you to join the service vide Ministry's directive dated 15.12.2017 & further extension to join the service is not warranted. Now, therefore, **your candidature for the Civil Service Examination/Indian Forest Service Examination, 2016 is hereby cancelled.**
