
I am directed to refer to IGNFA's letter no. 1263/NFA-2019/70.21/(2019-21 Course) dated 19.09.2019 on the above subject and to say that **thirteen (13)** candidates (including Sh. Dinesh Kumar G (Rank 78), Ms. Kajol Patil (Rank-11), Ms. Kasturi Sule (Rank-56), and Sh. Bhorde Akshay Balu, Rank- 95 of IFS Exam 2017) out of total 34 candidates of IFS Exam, 2017, who were on one year extension, has been granted either exemption (of 3 months) from attending the FC in 2019 or permission to join the service directly at IGNFA, Dehradun in Dec, 2019.
