

It may be noted that in view of the proviso below Rule 3(3) of Indian Forest Service (Regulation of Seniority) Rules, 1997, they will be assigned the subsequent year i.e. 2020 as the year of allotment instead of 2019, as already stated in clause-6 of offer of appointment to you. **It may also be noted that no further extension/relaxation of time will be granted.**

3. Further, the competent authority has granted exemption from attending the 94th FC to thirty-eight (38) candidates of IFS Exam-2018 (as requested by them). They are directed to report to IGNFA, Dehradun for the Professional Course on the scheduled date. They are also directed to complete the Foundation Course (FC) at the earliest.

Further, the competent authority has permitted twenty (20) candidates of IFS Exam, 2018 to join the service/ 94th Foundation Course at training institutes assigned by the Lal Bahadur Shastri National Academy of Administration (LBSNAA) on the day designated by LBSNAA as per its training schedule i.e. 26.08.2019.


