Sub:- Indian Forest Service Examination, 2018 - Medical Examination (Part-I & II) and walking Test -Regarding.

Sir/Madam,

I am directed to say that you have qualified for the Medical Examination (Part I & II) and Walking test on the basis of the results of the Indian Forest Service Examination, 2018 declared by Union Public Service Commission. Accordingly, you are required to undergo Medical Examination and Walking Test as per schedule attached and instructions given below. **Please note that you must carry your original Admit Card for Medical Examination (Part-I & II) and Walking Test.**

1. MEDICAL EXAMINATION:-

(i) The physical standards prescribed for appointment to the Indian Forest Service (IFS), vide rule 18 of the IFS (Examination) Rules, 2018 are laid down in Appendix III available on the website <http://www.ifs.nic.in> and may please be carefully studied.

(ii) The Medical Examination will be conducted from **8th April to 12th April, 2019 (5 days)** by a duly constituted " Central Standing Medical Board" at the Safdarjung Hospital, New Delhi-110003 & Central Standing Medical Board" at the RML Hospital, New Delhi-110003.

Allocation of candidates to the hospital for medical test alongwith dates of medical examination and walking test has been indicated in the Annexure-I, respectively to this letter and no change whatsoever, will be allowed in this matter in any circumstances.

(iii) On the subject of medical examination, particular attention of the candidates is invited to the following:

(a) No fee is required to be paid by them for Medical Examination.

(b) The candidates are required to take with the them 10 passport size recent color photographs with white background, while reporting for Medical Examination.

(c) Candidates wearing glasses are required to carry a recent certificate indicating the power of the glasses being used.

(d) Candidates are requested to come fasting for 8-10 hours on the day of medical examination

(e) Candidates with doubtful colour vision are entitled to two sets of tests - by Ishihara's Plates and Edridge Green Lantern. While fulfillment of requirement by either of the Tests is considered sufficient, later appeals from candidates that they are adjudged UNFIT on test by only one of the tests without allowing to them the opportunity of being tested by the other, will not be considered. Such examination should be insisted upon and in case of the request not being agreed to by the Medical Board, a report lodged with the undersigned on the same, or on the following day of the Medical Examination.

(f) Presence of candidates may be required till 4.00 PM & for a further period of few days in case, investigation / hospitalization is considered necessary for which candidates are required to come prepared.

2. **WALKING TEST:**

(i) The requirements in this behalf are laid down in rule 18 ibid.

(ii) The Walking Test will be conducted in the Premises of the National Zoological Park (Delhi zoo), Mathura Road, New Delhi-110003.

(iii) Admission to the Walking Test is strictly subject to the following condition.

Candidates are required to furnish to this Ministry 5 copies of the Attestation Forms provided to them by UPSC, duly filled in, signed and verified. **They should not fail to indicate their Roll Number & Rank at the right hand top corner of the form (above their photographs) and their e-mail address/contact number in address column.**

Those candidates who have not sent their Attestation Form to this Ministry, either in person or through post, are required to submit the same to the Ministry's representatives at the time of Walking Test in the premises of the National Zoological Park, New Delhi.

For conduct of the walking test, candidates are required to report to the Director of the Zoo latest by **4:30 A.M.** on the designated day of the Test with **5 copies of recent passport size color photograph with white background. The date of the Test is indicated in the Annexure-I to this letter.**

3. **ADDRESS CHANGE & MISCELLANEOUS CORRESPONDENCE:-**

The candidates should intimate promptly to this Ministry, all change(s) in their mailing address, if other than mentioned by them in UPSC. **All correspondence should be addressed only to the following:**


