

In terms of DoP&T's O.M.No.14014/1/2011-AIS-(Part) dated 03rd May' 2013, if a State Forest Service is appointed to IFS on the basis of Select List which has been prepared in accordance with the ratio laid down by Hon'ble Punjab and Haryana High Court and confirmed by Hon'ble Supreme Court of India in Praveen Kumar's case, seniority rules as amended on 18/04/2012 will be applicable for year of allotment of the officer.
