



**Explanation (S.No 4): As per provisio under Explanation below Rule 3(3)(ii) of IFS (Regulation of Seniority) Rules, 1997, which states that he shall not be assigned a year of allotment earlier than the year of allotment assigned to an officer senior to him in that select list or appointed to the service on the basis of an earlier select list.*

2. It is stated that the seniority of officers from 2016 batch onwards are based on their rank, which would undergo change once decided. Accordingly, the first SFS officer would always be just below the junior most RR officer of that batch.
