Sir,

I am directed to your letter/e-mail dated 20.06.2019 on the subject cited above and to say that your attention is drawn to the Note below rules 12 of Regulations relating to Physical Examination of candidates contained in Appendix III of Rule 18 of IFS Examination Rules which inter alia reads as:

“.....there is no right of appeal from Medical Board special or standing appointed to determine their fitness for the above service. If, however, Government are satisfied on the evidence produced before them of the possibility of an error of judgement in the decision of the first Board, it is open to Government to allow an appeal to second Board. Such evidence should be submitted within one month of the date of the communication in which the decision of the first Medical Board is communicated to the candidate, otherwise no request for an appeal to a second Medical Board will be considered.

If any medical certificate, produced by a candidate as a piece of evidence about the possibility of an error of judgement, in the decision of the first Board, the certificate will not be taken into consideration unless it contains a note by **the medical practitioner concerned to the effect that it has been given in full knowledge of the fact that the candidate has already been rejected as unfit for service by the Medical Board.**”

2. In this regard, it is informed that the medical certificate, as submitted by you to support your appeal against the decision of 1st Central Standing Medical Board (CSMB), has not contained a note by the medical practitioner concerned to the effect that it has been given in full knowledge of the fact that the you have already been rejected as unfit for service by the Medical Board.” **It is, therefore, requested to submit the medical certificate as mentioned above.**

3. This issues with the approval of competent authority.
