NOTIFICATION

GSR No . .827 E. . In exercise of the powers conferred by sub-section (I) of section 3 of All India Services Act, 1951 (61 of 1951), read with Section 71(2) and 71(3) of the Bihar Reorganisation Act, 2000 and the first proviso to sub-rule (2) of Rule 4 of the Indian Forest Service (Cadre) Rules, 1966, the Central Government, in consultation with the Government of **Bihar** hereby makes the following regulations further to amend the Indian Forest Service (Fixation of Cadre Strength) Regulations, 1966, Namely:-

1. (i) These Regulations may be called the Indian Forest Service (Fixation of Cadre Strength) First Amendment Regulations, 2000.
(ii) They shall come into force with effect on the First day of November 2000.
2. In the Schedule to the Indian Forest Service (Fixation of Cadre Strength) Regulations, 1966, for the heading "**Jharkhand**" and the entries occurring thereunder, the following shall be substituted, namely:-
