

Minutes of the Meeting of the Screening Committee held on 18.12.2018 at 03.30 PM to prepare the "OFFER LIST" for DIGF/AIGF level posts under the Central Staffing Scheme of MoEF&CC.

The Meeting of the Screening Committee for recommending names/panel for inclusion in the "OFFER LIST" for the posts at the level of Deputy Inspector General of Forests (DIGF) and Assistant Inspector General of Forests (AIGF) was held on 18.12.2018 under the Chairpersonship of ADGF (FC). The following were present in the meeting:

The Committee was assisted by Smt. Anuradha Singh, Dir(IFS) and Shri Ashok Kumar. US(IFS-1).

2. The Committee was apprised that minimum years of service for DIGF and AIGF level posts will be with reference to 01.01.2018 and cooling off must be complete as per extant guidelines.

3. The Committee was apprised that in the vacancy circular dated 20.07.2018, it is also mentioned that as per provisions contained in para 4 of the Central Staffing Scheme of MoEF&CC dated 06.05.2011, in exceptional cases, where sufficient number of IFS officers are not available for the appointment to specific posts, the officers borne on the State Forest Service (SFS) whose names are included in the 'Select List' referred to in Regulation 7(3) of the IFS (Appointment by Promotion) Regulations, 1966, shall also be considered for selection for appointment. In case of posts in the North Eastern Region, the SFS officers who are yet to be included in the 'Select List' referred to above, shall also be considered.

4. The Committee while considering the names for inclusion in the "OFFER LIST" against the vacant/likely to fall vacant posts at the level of DIGF and AIGF under the Central Staffing Scheme of CSS-MoEF&CC, took into account their Annual Confidential Reports (ACRs)/Performance Appraisal Reports (PARs) grading and other relevant records for ascertaining their suitability.





6. A meeting of the Screening Committee had been earlier scheduled for 16.10.2018 where ADFC(FC) and ADGF(WL) were present. While going through the details regarding eligibility as well as number of applications received against the posts notified, it was observed that number of applications within time were far fewer than the total number of posts notified. In order to make the exercise of filling up the posts worthy, a view was taken to consider all applications received till the date of Screening Committee meeting. However, since JS(IFS) was not available and subsequently proceeded on long leave, the Screening Committee meeting could not be finalized due to lack of quorum.

7. The Committee has been apprised that advance copy of application from two more IFS officers viz. T. Gnana Prakash, IFS(PB:1993) and Kunal Satyarthi, IFS(HP:1997) has been received after earlier scheduled meeting of Screening Committee on 16.10.2018. The Committee has taken into consideration the fact that applications received at DIGF and AIGF level are fewer than the posts advertised at DIGF and AIGF level, and decided to consider all the applications including advance copies received before this meeting for inclusion in the offer list. It has also been decided that in respect of advance copies, the application through proper channel should be received in the Ministry before the meeting of Central Forestry Establishment Board. Further, it was also decided that in case of applications which were received in response to previous vacancy circulars through proper channel after the last date and the concerned officers has requested to consider their earlier applications against previous vacancy circulars (if any) for the present vacancy circular may also be considered.
