Sir,

I am directed to refer to Government of Jharkhand letter No. Bha. Va. Se.(Stha.) 174/2000 4199 V.P. dated 07.09.2016 and to inform that Central Forestry Establishment Board has recommended the appointment of Shri Karma Zimpa Bhutia, IFS (JHK:1997) to the post of Conservator of Forests, Regional Office, Chandigarh, Ministry of Environment, Forest and Climate Change on tenure deputation basis under the Central Staffing Scheme of this Ministry on the following terms and conditions:
