Sub: Nomination of Indian Forest Service officer to the post of Chief Forest Officer (at the level of General Manager) in NTPC on tenure deputation basis for a initial period of three years - regarding.

Sir/Madam,

The Ministry of Environment and Forests invites applications of suitable IFS officer for appointment against one post of **Chief Forest Officer** (at the level of CCF) in the scale of **E-8 (i.e Rs 51300-73000 plus perks)** in NTPC on tenure deputation basis for a initial period of three years, extendable upto 5 years. Basic pay & allowances of parent department, in addition and the incumbent will also be entitled for company accommodation / company leased accommodation vehicle as per entitlement of E-8 in NTPC, medical facility/ PRP/ incentives as per NTPC rules. The Chief Forest Officer will report directly to the Director (HR), NTPC.

2. NTPC will be forwarded the list of willing IFS officers, at the level of CCF and having experience and comprehensive knowledge of systems and procedures for acquisition of forest land and for undertaking restoration and rehabilitation work. The officer is expected to coordinate with Ministries/Organizations dealing with forest, mining and related environmental and legal issues and involving clearance for big projects of NTPC.

3. It is therefore requested to forward the nominations of eligible and the willing officers who are clear from vigilance angle and whose services can be spared. Officers who have completed one spell of central deputation may be considered for a further spell of central deputation only after they have completed the stipulated cooling off period or will be completing cooling off period by **15th July, 2013**. It is clarified that the cooling off period is reckoned from the date the officer reports back to his/her cadre on completion of earlier deputation tenure. The deputation will be in accordance with the DoPT deputation guidelines for AIS officers.

Applications received after the last date will also not be considered. However, the competent authority may relax any of the conditions, if considered necessary to do so.
