2. It is informed that the Central Forestry Establishment Board has recommended the name of Shri Rama Shankar Sinha, IFS (AGMUT:1995), Director, Ministry of AYUSH, for his appointment as Additional Commissioner (Forestry), Department of Agriculture & Cooperation, New Delhi on tenure deputation basis under the Central Staffing Scheme of this Ministry.
3. In terms of DoPT's Office Memorandum No. AB-14017/2/2007-Estt.(RR) dated 29.02.2008, the said officer will be eligible for the maximum deputation period of 07 years (combined tenure under CSS/Non-CSS of DoPT) upto 02.01.2020.
4. Since the said officer is presently under the Central Staffing Scheme of DoPT, it is requested that Shri Rama Shankar Sinha, IFS(AGMUT:1995) may be relieved after obtaining necessary clearance from DoPT so that to enable him to join the post on 07.12.2016
5. Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government under CSS-MoEF&CC.
