Subject: Appointment of Shri Anjan Kumar Mohanty, IFS (SK:1992), Director, Department of Social Justice and Empowerment, New Delhi as Deputy Inspector General of Forests (DIGF), Ministry of Environment, Forest and Climate Change, on tenure deputation basis under CSS-MoEF&CC.

The undersigned is directed to refer to Ministry of Social Justice and Empowerment's Office Memorandum No. A-19011/29/2013-Estt. I dated 28.07.2015 on the subject mentioned above.

2. It is informed that the Central Forestry Establishment Board has recommended appointment of Shri Anjan Kumar Mohanty, IFS (SK:1992), Director, Department of Social Justice and Empowerment, New Delhi, to the post of Deputy Inspector General of Forests (DIGF), Ministry of Environment, Forest and Climate Change, on tenure deputation basis under the Central Staffing Scheme of this Ministry. **The deputation tenure of Shri Mohanty will be upto 16.10.2018.**

3. In terms of DoPT's Office Memorandum No. AB-14017/2/2007-Estt.(RR) dated 29.02.2008, Shri Mohanty will be eligible for the maximum deputation period of 07 years (combined tenure under CSS/Non-CSS of DoPT) upto 16 October, 2020 subject to NOC from the Government of Sikkim.

4. Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government under CSS-MoEF&CC.

5. It is requested to relieve Shri Anjan Kumar Mohanty, Director, at the earliest to enable him join as DIGF in this Ministry.
