
Sir,

I am directed to refer to Government of Jammu & Kashmir letter No.FST/Ser/APRs/70/2015 dated 13.03.2017 and to inform that Central Forestry Establishment Board has recommended appointment of Shri Chaturbhuj Behera, IFS(JK:1996) to the post of Conservator of Forests, Regional Office, MoEF&CC, Bhopal on tenure deputation basis under the Central Staffing Scheme of this Ministry on the following terms and conditions:

- (i) He will draw pay as per the scale allowed by the Cadre Controlling Authority plus Central Deputation Allowance as applicable to that grade.
- (ii) The central deputation of the officer will for 05 years from the date of joining to the post or until further orders whichever is earlier.
- (iii) The headquarters of the post will be at Bhopal however the services of the officer can be utilized anywhere in India.
- (iv) Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEF&CC.
