Sir,

I am directed to refer to Government of Uttar Pradesh letter No.641/14-1-2017-300(13)/2001 dated 16.03.2017 and to inform that Central Forestry Establishment Board has recommended appointment of Shri Sujoy Banerjee, IFS(UP:1997) to the post of Deputy Inspector General of Forests, Department of Land Resources, New Delhi on tenure deputation basis under the Central Staffing Scheme of this Ministry on the following terms and conditions:
