Kindly refer to this Ministry's letter No. 12034/10/2014-IFS-I dated 2.3.2015 and letter No. 12034/03/2015-IFS-I dated 2.3.2015 vide which all State Governments were requested to provide CVC pro-forma etc. in respect of IFS officers of 1993 and 1994 batch as the empanelment process at JS and equivalent is in progress. In the meantime 1995 batch has also become eligible and is under consideration for empanelment. It has been our experience that non receipt of complete information from State Govt. leads to delays in process of empanelment. Therefore, it is requested that while forwarding the information in respect of those officers special attention be paid to following points.

- (i) Duly filled CVC pro-forma. It may please be ensured that there is no gap in posting details, no columns are left blank, the pro-forma is ink signed and duly stamped & properly dated.
- (ii) Copy of Immovable Property Return for the year 2014 (as on 01.01.2015) is enclosed. The immovable property return may also be duly filled and uploaded on the website [www.ifs.nic.in](http://www.ifs.nic.in)
- (iii) Availability status of ACRs/PARs has been uploaded and can be perused at IFS website i.e. [www.ifs.nic.in](http://www.ifs.nic.in) ACR status link. Original/duly attested ACRs/PARs which are not available as per this site may be sent.
- (iv) Date of grant of super time scale (Grade Pay Rs. 10,000/-) to the officer.
