I am directed to refer to Government of Arunachal Pradesh letter No. FOR.419/EA/89/VII/Pt/140-41 dated 15.12.2015 and to inform that the Appointments Committee of the Cabinet (ACC) has approved appointment of **Shri C. H. Murlidhar Rao, IFS (AGMUT:1985)** to post of **Additional Principal Chief Conservator of Forests (APCCF), Regional Office, MoEF&CC, Bangalore** in pay scale Rs 67,000-79,000/- (pre-revised) on deputation basis under CSS-MoEF on the following terms and conditions:

- (i) He will draw pay as per the scale allowed by the Cadre Controlling Authority plus Central Deputation Allowance as applicable to that grade.
- (ii) The central deputation tenure of the officer will be from the date of assumption of charge and till 31.07.2020 i.e. date of superannuation or until further orders whichever is earlier.
- (iii) The headquarters of the post will be at Bangalore however the services of the officer can be utilized anywhere in India.
- (iv) Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEF&CC.

2. The State Government is requested to relieve **Shri C. H. Murlidhar Rao, IFS (AGMUT:1985)** immediately to enable him to join the above post at Bangalore.
