Sub: Indian Forest Service Examination 2017 (Batch 2018) - Cancellation of candidature - regarding.

Sir,

I am directed to say that on the basis of results of IFS Examination, 2017 and result of Medical Examination & Walking Test, offer of appointment to the Indian Forest Service was offered to you, vide Ministry's letter of even no. dated 03.07.2018.

2. Further, Ministry vide its letter of even no. dated 19.07.2018 has intimated/directed all the finally selected candidates to submit their request regarding either extension of one year to join service with the subsequent batch or exemption from 93rd Foundation Course (FC), whichever they wish to avail, latest by 23.07.2018 failing which no request will be considered thereafter.

3. Whereas, you vide your e-mail dated 23.07.2018 requested the Ministry to grant exemption to you from attending 93rd Foundation Course (FC) (i.e. exemption of 3 months not extension of one year). Accordingly, the Ministry vide its letter of even no. dated 03.08.2018 acceded the same, **with the direction to report IGNTA, Dehradun for joining Professional Course on scheduled date.**

4. Whereas, after the expiry of above mentioned due date i.e. 23.07.2018, you vide your 2nd time e-mail dated 10.12.2018 informed the Ministry that due to **inevitable circumstances**, you were not able to join this batch of training at IGNTA, Dehradun and requested the Ministry to permit you to join the service with the next batch of training and approve your request for granting one year extension.

5. Whereas, Ministry has examined your request dated 10.12.2018 and has decided that your act of not joining the service/duty on scheduled date despite the Ministry's direction to report at IGNTA, Dehradun amounts to clear disobedience of the Ministry's directive dated 19.07.2018 & 03.08.2018.

6. However, Ministry vide its letter of even no. dated 19.12.2018 granted a final opportunity to you to report for service/duty at IGNFA, Dehradun latest by 24.12.2018, failing which process for cancellation of your candidature by issuing show cause notice would be initiated.

7. Whereas, the Course Director at IGNFA, Dehradun vide its e-mail dated 31.12.2018 has informed the Ministry that Sh. Rahul Gajbhiye has not joined for professional training as on 31.12.2018 to this academy.


8. Accordingly, Ministry vide its letter of even no. dated 28.01.2019 has directed you to show cause within 15 (fifteen) days as to why your candidature should not be cancelled for the Civil Service Examination/Indian Forest Service Examination, 2017 for unauthorized absence from joining the service/duty at IGNFA, Dehradun on scheduled date.

9. Whereas, you have submitted your representation to the Ministry vide your letter dated 12.02.2019 in response to the Ministry's above mentioned show cause notice.

10. Whereas, the Ministry has examined your representation and it has been decided that ample time has been given to you to join the service & further extension to join the service is not warranted. Now, therefore, **your candidature for the Civil Service Examination/Indian Forest Service Examination, 2017 is hereby cancelled.**

11. This issues with the approval of Hon'ble MEF&CC.
