For this, the concerned State Government/UT Administration authorities are requested to take a print of the Civil List w.r.t. respective cadre as on 01.01.2022 (Civil List available on the website <http://www.ifs.nic.in> and mark the corrections/changes if any, in RED ink only and indicate (i) State of Domicile & (ii) Category of the officer also. This may be scanned and mailed to the Ministry by e-mail at ifs@nic.in. It may please be noted that the draft Civil List sent in any other format will not be accepted.


3. In the information, reasons for any change/addition/deletion may clearly be indicated. If necessary, a separate sheet may be used.

4. It is also requested that the States and UTs may kindly ensure that the information is scrutinized properly, at appropriate level.
