I am directed to refer to Government of Uttar Pradesh letter No. 1930(1)/81-1-2019-300(4)/97 dated 22.11.2019 and to inform that the Appointments Committee of the Cabinet (ACC) has approved appointment of Shri Shri Bivash Ranjan, IFS(UP:1989) to the post of Deputy Director General of Forests (Central), Regional Office, MoEF&CC, Lucknow in the pay scale Rs 67,000-79,000/- (pre-revised) on deputation basis under Central Staffing Scheme of Ministry of Environment, Forest & Climate Change (CSS-MoEFCC) on the following terms and conditions:

- (i) He will draw pay as per the scale allowed by the Cadre Controlling Authority plus Allowances as applicable to that grade.

  - (iii) The headquarters of the post will be at Lucknow however the services of the officer can be utilized anywhere in India.
  - (iv) Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEFCC.
2. The State Government is requested to relieve Shri Bivash Ranjan, IFS(UP:1989) in time so as to enable him to join the above post w.e.f. 01.07.2020.
