- iv. Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEFCC.

2. The Ministry of Jal Shakti, Department of Water Resources (DoWR) is requested to relieve Shri Anand Mohan, IFS (RJ:1996), presently posted as Joint Secretary in DoWR, RD&GR, with the direction to take up his new assignment on or after 01.05.2025.
