- (iv) Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEFCC.

2. The State Government is requested to relieve Shri Gobind Sagar Bhardwaj, IFS(RJ:1994) at the earliest with the direction to take up his new assignment.
