



1. The Chief Secretary, Government of Telangana, Hyderabad- It is requested that the officers may please be informed of the aforesaid Select Lists under intimation to this Ministry. - (iii) A certificate by the State Government that there is no stay order of any court prohibiting the appointment of State Forest Service officers by promotion to the Indian Forest Service, Telangana.
- (iv) A certificate by the State Government, that there is no disciplinary/vigilance case pending /contemplated against the officers recommended for promotion.
- (v) A certificate by the State Government that the officers are in service as on date.
