I am directed to refer to Government of Haryana letter No. 2035-FT-2-2021/2758 dated 05.07.2021 and to inform that the Appointments Committee of the Cabinet (ACC) has approved appointment of Dr. T. P. Singh, IFS(HR:1996) to the post of Inspector General of Forests (IGF), MoEFCC, New Delhi in level 14 of the Pay Matrix, on deputation basis under Central Staffing Scheme of Ministry of Environment, Forest & Climate Change (CSS-MoEFCC) on the following terms and conditions:

- (i) He will draw pay as per the scale allowed by the Cadre Controlling Authority plus Allowances as applicable to that grade.
- (ii) The central deputation tenure of the officer will be for a period of 05 years w.e.f. the date of assumption of charge of the post (on or after 15.10.2022), or till attaining the age of superannuation, or until further orders, whichever is earliest.
- (iii) The headquarters of the post will be at New Delhi, however the services of the officer can be utilized anywhere in India.
- (iv) Other terms and conditions will be the same as applicable to the other officers of his grade on deputation to the Central Government and as per CSS-MoEFCC.

2. The State Government is, therefore, requested to relieve Dr. T. P. Singh, IFS(HR:1996) with the direction to take up his new assignment on 15.10.2022.
