G.S.R. 282.11. In exercise of the powers conferred by sub-section (1) read with sub-section (1A) of section 3 of the All India Services Act, 1951 (61 of 1951), the Central Government, after consultation with the State Governments of the States concerned, hereby makes the following rules further to amend the Indian Forest Service (Probation) Rules, 1968, namely:-

1. (1) These rules may be called the Indian Forest Service (Probation) Amendment Rules, 2007.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Indian Forest Service (Probation) Rules, 1968, in rule 3, for sub-rule (2), the following shall be substituted, namely


"Every person recruited to the Service in accordance with the Indian Forest Service (Appointment by Competitive Examination) Regulations, 1967 or the Indian Forest Service (Released Emergency Commissioned and Short Service Commissioned Officers) (Appointment by Competitive Examination) Regulations, 1968 shall be appointed to the Service on probation for a period of two years."
