NOTIFICATION

In exercise of the powers conferred by sub-rule (1) of Rule 5 of the Indian Forest Service (Cadre) Rules, 1966, the Central Government in consultation with the State Governments concerned, hereby allocate the officers mentioned in column 2 of the table below, to the cadres mentioned in the corresponding entry in column 3 thereof.


