NOTIFICATION

GSR No . . 173 In exercise of the powers conferred by sub-section (I) of section 3 of All India Services Act, 1951 (61 of 1951), read with rule 4 of the Indian Forest Service (Cadre) Rules, 1966, the Central Government, in consultation with the Government of **Uttar Pradesh** hereby makes the following regulations further to amend the Indian Forest Service (Fixation of Cadre Strength) Regulations, 1966. Namely:-

1. (i) These Regulations may be called the Indian Forest Service (Fixation of Cadre Strength) Second Amendment Regulations, 2003.
(ii) They shall come into force on the date of their publication in the official Gazette.
2. In the Schedule to the Indian Forest Service (Fixation of Cadre Strength) Regulations, 1966, for the heading "**Uttar Pradesh**" and the entries occurring thereunder, the following shall be substituted, namely:-

Note : The four posts of Chief Conservator of Forests namely (1) Chief Conservator of Forests/ Director, State Forest Research Institute, Kanpur (2) Chief Conservator of Forests /Director, Forest Training Institute, Kanpur (3) Chief Conservator of Forests (Eco-Development) Lucknow and (4) Chief Conservator of Forests (Joint Forest Management) Lucknow are temporary addition to the cadre and are created only for three years by keeping in abeyance 4 posts of Conservator of Forests. After the

lapse of the said period four posts of Conservator of Forests with the same nomenclature shall come into existence. Therefore, after three years the number of posts of Chief Conservator of Forests will be decreased to 8 and the number of posts of Conservator of Forests shall be increased to be 34.
