Subject: - Indian Forest Service Examination, 2015 – Medical Examination (Part-I & II) and Walking Test- regarding.

I am directed to say that you have qualified for **Medical Examination (Part-I & II) and Walking Test** on the basis of results of the Indian Forest Service Examination 2015 declared by the Union Public Service Commission. The **Medical Examination (Part-I & II) and Walking Test** will be conducted from **29th February, 2016 to 4th March, 2016**. Accordingly, you are required to undergo Medical Examination and Walking Test as per schedule attached and instructions given below. **Please note that you must carry your original Admit Card for Medical Examination (Part-I & II) and Walking Test.**

1. MEDICAL EXAMINATION:-

- (i) The physical standards prescribed for appointment to the Indian Forest Service (IFS), vide rule 17 of the IFS (Examination) Rules, 2015 are laid down in Appendix III available on the website <http://www.ifs.nic.in> and may please be carefully studied.
- (ii) The Medical Examination will be conducted by a duly constituted **“Central Standing Medical Board”** at the following Hospitals in New Delhi, viz:
 - a). Safdarjung Hospital & VMMC, New Delhi-110003
 - b). Dr. Ram Manohar Lohia Hospital, New Delhi-110001. (Also known as Willingdon Hospital)

Division of candidates amongst the above two Hospitals for medical test alongwith dates of medical examination (Part- I & II) and walking test has been indicated in the **Annexures I and II** respectively to this letter and **no change whatsoever, will be allowed in this matter in any circumstances.**

- (iii) On the subject of Medical Examination, Particular attention of the candidates is invited to the Following:
 - (a) No fee is required to be paid by them for Medical Examination.
 - (b) The candidates are required to take with them **five passport size photographs**, while reporting for Medical Examination.
 - (c) Candidates wearing glasses are required to carry a recent certificate indicating the power of the glasses being used.

- (d) Candidates with doubtful colour vision are entitled to two sets of tests- by Ishihara's Plates and Edridge Green Lantern. While fulfillment of requirement by either of the Tests is considered sufficient, later appeals from candidates that they were adjudged UNFIT on test by only one of the tests without allowing to them the opportunity of being tested by the other, will not be considered. Such examination should be insisted upon and in case of the request not being agreed to by the Medical Board, a report is to be lodged with the undersigned on the same day or on the following day of the Medical Examination.
- (e) Candidates using glasses should bring spectacles with latest prescription.
- (f) Presence of candidates may be required till 4.00PM & for a further period of few days in case, investigation /hospitalization is considered necessary for which candidates are required to come prepared.

II. WALKING TEST:

- (iii) The requirements in this behalf are laid down in rule 17 ibid.
- (iv) The Walking Test will be conducted in the "Premises of the National Zoological Park (Delhi Zoo)", Mathura Road New Delhi-110003.
- (iii) Admission to the Walking Test is strictly subject to the following condition:

Candidates are required to furnish to this **Ministry, 5 copies** of the Attestation Forms provided to them by the UPSC, duly filled in, signed and verified. They should not fail to **indicate their Roll Number at the right hand top corner of the form (above their photographs) and their e-mail address / contact number in address column. The Envelope must be superscribed "Indian Forest Service Examination- 2015 "**

Those candidates who have not sent their Attestation Form to this Ministry, either in person or through post, are required to submit the same to the Ministry's representatives at the time of Walking Test in the premises of the National Zoological Park, New Delhi.

For conduct of the Walking Test, candidates are required to report to the Director of the Zoo at the appointed time on the designated day of the Test with **3 copies of recent passport size photograph**. The date of the Test is indicated in the Annexure to this letter. Request for postponement of the Walking Test will not be entertained except under exceptional circumstances, which should be supported, by necessary reasoning / proof.
