NOTIFICATION

The Accountant General is being instructed not to pay salary etc. for any period beyond the approved period of deputation.

As such, the officer shall be entitled to draw salary, etc. in the State to which he/she has been deputed only for the period for which he/she has been allowed deputation by the Government of India. He/she shall not be entitled to draw salary etc. after expiry of the period of deputation.
