Minutes of the Meeting of the Screening Committee held on 19.12.2017 at 11.00 A.M. to prepare the "OFFER LIST" for appointment to the post of Director General, Forest Survey of India, Dehradun (APCCF level post) under the Central Staffing Scheme of MoEF&CC.

The Meeting of the Screening Committee for recommending names/panel for inclusion in the "OFFER LIST" for appointment to the post of Director General, Forest Survey of India, Dehradun (APCCF level post) was held on 09.11.2017 in the chamber of Director General of Forests & Special Secretary, Ministry of Environment and Forests, Indira Paryavaran Bhawan, Jor Bagh Road, New Delhi.

3. The Committee while considering the names for inclusion in the "OFFER LIST" against the vacant post of DG, FSI, Dehradun took into account their Annual Confidential Reports (ACRs)/Personal Appraisal Reports (PARs) grading and other relevant records as well as the following and other eligibility conditions notified for the purpose for ascertaining their suitability:

- (i) Minimum 26 years of service with reference to the Year of Allotment in IFS.
- (ii) The officer under consideration should have a minimum of 03 years of service left before superannuation.
- (iii) Minimum of 26 years of service will be with reference to 01.01.2017 and the minimum of three years of service left before superannuation will be counted from 01.01.2017.
- (iv) The officer should have completed mandatory cooling off period of one year.

4. The Screening Committee also set the following criteria for inclusion of officers in "OFFER LIST":

- (i) Vigilance Clearance Certificate.
- (ii) Out of 72 marks (maximum) considering 8 ACRs/PARs, qualifying benchmark of 62 marks was fixed.


