

Minutes of the Meeting of the Screening Committee held on 01.04.2015 at 11.00 AM to prepare the "OFFER LIST" for DIGF/AIGF level posts under the Central Staffing Scheme of MoEF&CC.

The Meeting of the Screening Committee for recommending names/panel for inclusion in the "OFFER LIST" for the posts at the level of Deputy Inspector General of Forests (DIGF) and Assistant Inspector General of Forests (AIGF) was held on 01.04.2015 in the chamber of ADGF(WL), Ministry of Environment, Forest and Climate Change, Indira Paryavaran Bhawan, Jor Bagh Road, New Delhi. The Committee was apprised that in the vacancy dated 26.12.2014 circular, it was also mentioned that the officers who have already applied through proper channel in response to the earlier vacancy circular No. 12026/09/2014-IFS-I dated 14.10.2014 (which was a short notice circular) need not apply again. Accordingly, applications of those officers who had earlier applied through proper channel but could not be appointed have also been included.

3. The Committee was also apprised that in addition to the details of applications received which have been mentioned in the Annexure-II and Annexure-IV, one more application from Ms. K. Pradeepa, IFS (MH:2005) for AIGF level post have been received before the meeting and was also placed before the Committee.

4. The Committee considered all applications including advance copies. It was decided that in respect of advance copies, the application through proper channel should be received in the Ministry before the meeting of the Central Forestry Establishment Board (CFEB).

The Committee while considering the names for inclusion in the "OFFER LIST" against the vacant/likely to fall vacant posts at the level of DIGF and AIGF under the Central Staffing Scheme of CSS-MoEF&CC, took into account their Annual Confidential Reports (ACRs)/Performance Appraisal Reports (PARs) grading and other relevant records for ascertaining their suitability.


